

## **Data Protection Statement**

Best Time Limited provides work-finding services to its clients and work-seekers. We must process personal data (including sensitive personal data) so that we can provide these services – in doing so, we act as a data controller. This is why we have asked for your personal data on this form. When we process your personal data we must do so in accordance with data protection laws. Those laws require us to give you a Privacy Statement to explain how we manage your personal data.

## **Annex A – Data Protection Privacy Statement**

In this Annex we explain how Best Time Limited manages your personal data.

### **Collection and use of personal data**

#### **a. Purpose of processing and legal basis**

Best Time Limited will collect your personal data (which may include sensitive personal data) and will process your personal data for the purposes of providing you with work-finding services. This includes for example, contacting you about job opportunities, assessing your suitability for those opportunities, updating our databases, putting you forward for job opportunities, arranging payments to you and developing and managing our services and relationship with you and our clients.

In some cases we may be required to use your data for the purpose of investigating, reporting and detecting crime and also to comply with laws that apply to us. We may also use your information during the course of internal audits to demonstrate our compliance with certain industry standards.

The legal bases we rely upon to offer these services to you are:

- Your consent
- Where we have a legitimate interest
- To comply with a legal obligation that we have
- To fulfil a contractual obligation that we have with you

#### **b. Legitimate interest**

This is where Best Time Limited has a legitimate reason to process your data provided it is reasonable and does not go against what you would reasonably expect from us. Where Best Time Limited has relied on a legitimate interest to process your personal data our legitimate interests is/are as follows:

#### **c. Recipient/s of data**

Best Time Limited will process your personal data and/or sensitive personal data with the following recipients:

- Clients/Hirer

- Accountant

**d. Statutory/contractual requirement**

Your personal data is required by law and/or a contractual requirement (e.g. our client may require this personal data), and/or a requirement necessary to enter into a contract. You are obliged to provide the personal data and if you do not the consequences of failure to provide the data are:

- We might not be able to find work placement.

**Data retention**

Best Time Limited will retain your personal data only for as long as is necessary for the purpose we collect it. Different laws may also require us to keep different data for different periods of time.

The Conduct of Employment Agencies and Employment Businesses Regulations 2003, require us to keep work-seeker records for at least one year from (a) the date of their creation or (b) after the date on which we last provide you with work-finding services. We must also keep your payroll records, holiday pay, sick pay and pensions auto-enrolment records for as long as is legally required by HMRC and associated national minimum wage, social security and tax legislation.

Where Best Time Limited has obtained your consent to process your personal/[and] sensitive personal data, we will do so in line with our retention policy. Upon expiry of that period [Insert agency name] will seek further consent from you. Where consent is not granted Best Time Limited will cease to process your personal data/[and] sensitive personal data.

**Your rights**

Please be aware that you have the following data protection rights:

- The right to be informed about the personal data Best Time Limited processes on you;
- The right of access to the personal data Best Time Limited processes on you;
- The right to rectification of your personal data;
- The right to erasure of your personal data in certain circumstances;
- The right to restrict processing of your personal data;
- The right to data portability in certain circumstances;
- The right to object to the processing of your personal data that was based on a public or legitimate interest;
- The right not to be subjected to automated decision making and profiling; and
- The right to withdraw consent at any time.

Where you have consented to Best Time Limited processing your personal data/[and]sensitive personal data you have the right to withdraw that consent at any time by contacting Best Time Limited on [contact@besttimeltd.com](mailto:contact@besttimeltd.com)

There may be circumstances where Best Time Limited will still need to process your data for legal or official reasons. We will inform you if this is the case. Where this is the case, we will restrict the data to only what is necessary for the purpose of meeting those specific reasons.
